Dear Members

3. GOVERNANCE

a. EC Meetings

Meeting minutes were drafted and circulated for all the meetings among the members and acknowledged. Due procedures for sending the agenda notes before the meeting were meticulously followed.

The strong attendance at each meeting ensured that NISTI affairs and activities were well deliberated and decided by consensus.

b. Statutory Audit

The statutory audit conducted by M/s Sanjay Rastogi & Company, has generated audit reports of NISTI for FY 22-23. Details shall be presented after approval of EC on 16th June 2023.

c. Filing of IT Return

IT returns have been filed in due time for the financial year 21-22 and acknowledgement received.

d. Revision of Constitution

The changes in the MoA passed in the 13th AGM were followed up with the Auditors and process initiated to update in the records of the Registrar of Societies. Meeting of the steering committee for revision in the AoA was held on4th March 2023 at Faculty Guest House at IIT Delhi. Dr. RA Lal, Prof. Vinod Shanbhag, Mr. Sudarshan Sharma, and Dr. Vijay Yadav attended the meeting.

The committee deliberated on criteria for the various categories of membership in NISTI, fees payable, and the reciprocal obligations and services to members from NISTI. The committee's deliberations shall continue, and recommendations placed for consideration by the executive council and general body in due course.

e. Internal Communication Media

Five WhatsApp groups, one each for NISTI members, EC members, Technical Textiles, NISTI Patrons and Office Bearers kept the wheels of communication in motion for informing and reporting outside of formal meetings. While these were strengthened for the day-to-day interactions, greater focus was made for reaching out to patrons, NISTI fraternity individually using WhatsApp.

f. Strengthening the Email Communication Groups

g. Fresh strides on social media

4. NISTI Founders Day Lecture

On May 18, 2023, the NISTI (Regd) marked its 35th Founder Day. NISTI was established on May 24, 1989, and later registered under the Societies Act on March 23, 2007. The commemorative event hosted Dr. Michael A. Saltzberg, CEO of Covation Biomaterials, who delivered an enlightening lecture on "The Future of Biomaterials". Attended by more than 80 participants from across India, the lecture highlighted key developments in biomaterials, particularly the innovative uses of Sorona® in textiles, Covation's collaborations in India, and the burgeoning opportunities for biomaterials in the South Asian market. Dr. Saltzberg also discussed Covation's sustainability initiatives and the challenges of enhancing biomaterial use. Dr. Akshay Kumar facilitated the event, showcasing the impressive manufacturing and testing facilities at Covation's Gurugram office. 5. EVENTS ORGANISED

a. Lectures and Seminars

- 1. 9th July 2022: NISTI invited Prof. Mukesh Kumar Singh from UPTTI (University Polytechnic, Uttar Pradesh Textile Technology Institute) to deliver a talk on "Smart Textiles for Emerging Business Opportunities." - 2. 7th August 2022: NISTI launched the first in a series of commemorative lectures on 7th August 2022 as part of the #AzadiKaAmritMahotsav. The inaugural lecture titled "Technical Textiles: Quo Vadis?" was delivered by Dr. Seshadri Ramkumar of Texas Tech University, a renowned researcher and innovator in the textile industry. The 90-minute session centered on the current status of Indian technical textiles and proposed strategies for its growth. The lecture sparked dynamic discussions with industry leaders, officials from the Ministry of Textiles-India, and other stakeholders. The event, lasting over two hours, was attended by government officials including the Joint Textile Commissioner, board members of leading textile associations like The Textile Association-TAI India, students, and academicians. - 3. 13th August 2022: As part of the AzadiKaAmritMahotsav celebrations, NISTI presented a webinar on "Sustainability in the Textile Industry." The event featured discussions by Dr. Arindam Basu, Director General of NITRA (North India Textile Research Association), Mr. Bharat Wadhwa, RM (Sales) Textiles Auxiliaries Asia Region at Croda India, and Mr. Sreedhar PR, Vice President of KG Fabriks. The topics covered included sustainability in the textile and apparel industry, role of fibers, and a 360-degree view on sustainability. The webinar received an overwhelming response from the audience which is evident from the discussions and the fact that 140+ attended the webinar. - 4. 9th September 2022: The North India Section of the Textile Institute Manchester (NISTI) held a webinar titled "Guidance Support for Higher Education in India and Abroad", led by Prof. Sunil Garg, an



experienced academic and industry professional. Prof. Garg leveraged his vast knowledge to provide insights about pursuing higher education in India and abroad. The webinar primarily focused on elucidating the prospects of studying in U.S. universities, highlighting opportunities like campus jobs, scholarships, and Curricular Practical Training (CPT). The presentation was skillfully conducted by Mr. Vilas Gharat, a well-known industry expert. He vividly explored the potential benefits of the fifth industrial revolution to the textile industry. This webinar drew a substantial audience, including textile professionals, students, entrepreneurs, and bureaucrats, all showing significant interest in the future of the textile industry. - 9. 4th February 2023: The "Khadi and Handloom for Sustainable Fashion" seminar was successfully held at IIT Delhi, hosted by NISTI (Regd) in collaboration with IIT Delhi's Department of Textile and Fibre Engineering, NITRA (Northern India Textile Research Association), and the Textile Sector Skill Council. The event aimed to highlight the importance of Khadi and Handlooms in sustainable fashion, stressing the urgency of sustainability in the fashion industry.
 - Ms. Roop Rashi, Textile Commissioner, was the Chief Guest, and her attendance significantly influenced the discussion. She acknowledged NISTI's initiative, advocating for more seminars and webinars that delve into sustainable textile manufacturing. Ms. Rashi was particularly appreciative of the creativity and innovation in the khadi and handloom sectors that boost marketability through branding. She underscored the vital role textiles play in India's economy and emphasized the necessity



for innovation to align the industry with sustainability principles. Ms. Rashi noted that textiles provide livelihoods to millions, hence the need for a synergistic approach across the value chain, from farmers to foreign markets. Circular economics in the textile industry was another significant point she raised, spotlighting the significance of recycling and upcycling. She advocated for collaborative efforts from market leaders and the government to promote sustainable products.

Mr. SK Jha, Sr. Director, National Crafts Museum and Hastkala Academy, emphasized the role of textiles, especially handlooms, in preserving cultural heritage. He viewed sustainable fashion as a challenge and opportunity for innovation. The seminar concluded with a commitment to promote sustainable fashion through handlooms and khadi, emphasizing innovation, circularity, and collaboration. The technical session featured enlightening talks from eminent individuals in the field, while the concluding panel discussion hosted by Dr. Vinod Shanbhag comprised a diverse panel of experts. The seminar was sponsored by Birla Cellulose, co-sponsored by Kaneka India Pvt. Ltd and Pashmina.com, and had Adileela Foundation as an organizing partner.

Dr. Vijay Yadav, Hon Secy NISTI, concluded the event with a vote of thanks, expressing gratitude to the speakers, attendees, sponsors, and media partners. NISTI (Regd) expressed sincere thanks to all participants and contributors and pledged continued efforts in promoting sustainable fashion in textile manufacturing.
